

SCENTED LIQUID RELEASE

Preferred Deck's **Scented Liquid Release** is a specially formulated, solvent bond-breaker that prevents textured mats from sticking to wet, cementitious material during the stamping process. It also eliminates coating-buildup on overlay mats. **Release** evaporates quickly and completely so there is no additional downtime (or extra steps needed) before coloring/sealing a Preferred Deck system.

APPLICATION TEMP: SUBSTRATE temperature must be between 50 - 115° F.

APPLICATION INSTRUCTIONS: Use pump sprayer to apply generous amount of **Release** on texture mats and wet overlay material. Use full strength. Apply **Release** to small area only (10-15 sq. ft.) to be immediately stamped. Use control joints in concrete to help determine area.

Read and understand all product labels, Technical Data Sheets and Safety Data Sheets (SDS) at www.prefdeck.com before purchasing/using products. Keep out of the reach of children.

COVERAGE RATE: Approximately 150 sq. ft. per gallon, depending on application technique and weather conditions. Evaporation time varies greatly, typically between 1-2 hours.

LIMITATIONS:

- Do not apply in extreme conditions. CONCRETE temperature MUST be at least 50° F and ambient temperature at least 60° F and rising.
- Do not allow product to freeze until applied/ fully cured.
- Do not use in hot afternoon sun, especially on dark surfaces, since surface can be over 115° F.
- Use in well-ventilated, exterior area due to solvent.
- Do not dilute.
- Overlay texture coat MUST dry overnight before applying Preferred Deck's **Decorative Stain**.

PACKAGING AND SHIPPING WEIGHTS:

1-gallon pail: 9 lbs. / 5-gallon bucket: 42 lbs.

SURFACE PREPARATION: A properly prepared substrate is key when applying a Preferred Deck system. Refer to **Aggregate** Technical Data Sheet for details.

DRY/CURE TIMES: Refer to **Aggregate** Tech Data Sheet.

CLEAN UP: Clean tools/equipment with MEK or other solvent. Use extreme care when using solvents and strictly adhere to warning labels.

STORAGE: Store in a well-ventilated place. Keep container tightly closed.

DISPOSAL: Dispose of contents/ container to an approved waste disposal plant.
